 - (1.3) Documents in support of consideration on qualifications of nominated person; i.e. educational background, work experience (curriculum vitae).
 - (1.4) Other documents to facilitate the consideration of the Board of Directors (if any).
- 2. This Form B shall be delivered within the deadline as specified in the announcement of B.Grimm Power noticed to the Stock Exchange of Thailand, in order to ensure sufficient period of time for the Board of Directors to consider the suitability of the nominated person for election as a director. B.Grimm Power shall deprive the rights of shareholders who provide incomplete or incorrect information, or cannot be contacted, or are not fully qualified; or the nominated person is not fully qualified or has any prohibited characteristics or have not proposed by the due date as specified by B.Grimm Power.
